Sealed or electronic bids must be submitted to the office of Godawari **Municipality, Attariya Kailali** by hand/courier or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np). on or before **12:00 Noon** on **2074/12/27**. Bids received after this deadline will be rejected. Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm** on **2074/12/27** at the Godawari Municipality Office , **Kailali**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. as following which shall be valid for 30 days beyond the validity period of the bid. Information to deposit the bid amount in Bank:
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
