- 4. Pre-bid meeting shall be held at Godawari *Municipality Office*, *Kailali*at 2:00 PM on 2074/12/07
- 5. Sealed or electronic bids must be submitted to the office of Godawari *Municipality, Attariya Kailali* by hand/courier or through PPMO website www.bolpatra.gov.np. on or before 12:00 Noon on 2074/12/21. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2074/12/22 at the Godawari Municipality Office, Kailali. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 261000.00 which shall be valid for 30 days beyond the validity period of the bid. Information to deposit the bid amount in Bank:
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
